Appendix Two: Types of Spaces and Places for Play

Children and young people play in a variety of spaces and settings, including:

Unsupervised Play Areas Such as Parks, Playgrounds, Skate Parks, Multi Use Games Areas (MUGA's), Playing fields . Children and young people generally access these types of settings unaccompanied by adults.

Staffed /Supervised Play Settings These include Out of School Clubs, Holiday Clubs, Pre-School and Play Projects where access is restricted. Play may not be the main focus of these settings, although opportunities for play are generally offered as part of their service

Open Access Play Settings Such as Adventure Playgrounds, Play Projects, Mobile or Outreach Play including Play Rangers, and some Holiday Clubs. Open Access settings mean children are free to come and go as they please.

Non-designated play spaces There are many other places where children play that do not fall into pre-defined categories. Children play anywhere and everywhere! They play in streets close to home, and in other public places such as outside shops and car parks.

Appendix Three: Links to National and Local Strategies and Plans

National Initiatives

In recent years, play has featured more prominently in government policy, initiatives and strategy.

Every Child Matters

Play makes a major contribution to the Government's Every Child Matters agenda. The benefits of children's play are closely linked to each of the five outcomes for children and young people that form the core of Every Child Matters:

- Being Healthy
- Staying Safe
- Enjoying and Achieving
- Making a positive contribution
- Achieving Economic Well-being

Play Specific National Initiatives

In the Government's **Children's Plan (2007)** the DCSF committed itself to publishing the first ever national **Play Strategy** which followed in 2008, showing a clear understanding of the value of play for children and families.

The Government's **Playbuilder Programme** has invested £235m in up to 3,500 play areas across the country. In Gloucestershire a £2m improvement programme is underway that 4 sites in Gloucester will benefit from.

Childcare

The Government's commitment to expanding childcare recognises children's needs alongside those of parents. Choice For Parents, The Best Start For Children sets out the Government's 10-year strategy to create a sustainable framework for high quality

integrated early years and childcare activities for all children and families. The strategy, which includes the development of school-based childcare and activities at both primary and secondary levels, will be implemented through the Every Child Matters framework.

Extended Services

The Extended Services agenda means that children are spending increasing amounts of their leisure time in the school environment. where free play provision is a key part of the service can have an important role in the play strategy, but it is important that its primary aim of providing play provision and opportunities for children is not diverted by the childcare or educational agendas.

Youth Matters

Youth Matters (published 2005) recognises the importance of providing positive activities, including unstructured as well as structured provision. Proposals set out in Youth Matters include a new duty on local authorities, working through Children's Trusts, to secure positive activities for young people, with plans for a new set of national standards and support for local authorities in developing a local offer to young people. These national standards aim to encompass the full range of 'exciting and enriching activities in which young people might wish to engage in their free time', including 'less structured activity that nonetheless contributes to a rich and varied life outside school or work, such as somewhere safe to hang out with friends'.

Children's Centre's

The Government is committed to delivering a Sure Start Children's Centre for every community by 2010. Children's Centres integrate services such as childcare, early years education, play, health and family support for children aged 0-5 and their families.

National Planning Guidance PPG17

The National Planning Guidance PPG17 outlines the importance of undertaking local assessments and developing local strategies for the provision of recreational space, including play areas.

Section 106 is the term used for a Planning Obligation, which is the means by which a developer contributes towards the provision of infrastructure and services associated with a proposed housing development. Such contributions can include local roads, public transport schemes, public open spaces, community facilities and affordable housing.

Local Context: Gloucestershire

Gloucestershire is a two tier authority and locally there are both County and six District strategies and plans that impact on play.

Gloucestershire County Council is responsible for leading the Change for Children programme locally through Gloucestershire's Children and Young People's Strategic Partnership (CYPSP). This is a partnership of the key local organisations that provide services for children and young people, providing the strategic steer for all multi-agency work related to services for children and young people in Gloucestershire. The CYPSP is Gloucestershire's Children's Trust - a Government requirement.

The key document that drives this work is Gloucestershire's Children and Young Peoples Plan which runs from 2009 to 2012. Under the Healthy Lifestyle priority one of the key

actions is that children, young people and their families are engaging in more physical activity. Active play can contribute to this priority.

In a review of progress in Gloucestershire's 2006-2009 Children and Young Peoples Plan, under Enjoy & Achieve, "more Play Rangers, leading to more opportunities and wider choice for children..." was cited as a success.

The CYPSP have tasked the Gloucestershire Play Partnership to produce a Countywide Play Strategy (called a Plan) which it endorsed in early 2010.

This Gloucester Play and Free Time Strategy shares the vision and key priorities of the County group - with actions relevant to the City of Gloucester.

The Gloucestershire Health and Well-being Partnership have an implementation plan (2009-2020) for tackling overweight and obesity in Gloucestershire. Physical activity which includes active play is part of this plan.

NHS Gloucestershire have published 'Tackling Obesity in Gloucestershire' (June 2009) which lists increasing children's participation in physical activity; the provision of affordable physical activity in the 10% most deprived Gloucestershire communities; and the development of more community based prevention / early intervention services as some of their key priorities. Active play can make a significant contribution to these priorities.

Local Context: Gloucester

Gloucester has an estimated population of 117,485 and a 'younger' age profile when compared to Gloucestershire as a whole. It has the highest proportion of children of all districts in the county (around 23,100 aged 0-15 years).

Gloucester has a higher rate of overcrowded housing and unemployment than elsewhere in the county. Around 8,200 people in Gloucester are from Black and other minority ethnic groups. This equates to 7.5% of the total population of Gloucester compared with 2.9% of the county population overall.

The Gloucester Partnership has an emphasis on sustainable communities and are working collectively towards the Sustainable Community Strategy 2008-2018. This Strategy sets out a plan of action for a prosperous future for Gloucester and to tackle current key issues. This is set against the city's changing background of regeneration, cultural and social needs and aligns to the Local Area Agreement (LAA).

Deprivation throughout England can be measured using the Indices of Multiple Deprivation (IMD) The IMD 2007 shows Gloucester to be the most deprived district in the county, with a number of local neighbourhoods in the wards of Podsmead, Matson & Robinswood, Westgate, Barnwood, Tuffley, Moreland, Barton and Tredworth and Kingsholm and Wotton, ranking in the most deprived fifth (20%) of local neighbourhoods nationally. The overall level of deprivation in Gloucester is significantly worse than the England average.
